High School:

If a judge is cancelled within 2 weeks of a meet, a fee of 2 hours

pay is due to the judge according to the terms of the contract. Extenuating circumstance, such as weather, can wave the payment on a case-by-case basis. Simply reducing the number of judges at the last minute will not waive the fee.

Also, Schools should provide a school map (even hand drawn) indicating the location of the competition gym to Bonnie. She will compile a list and distribute to the judges. Newer judges are not always familiar with some of the larger campuses and the gym/parking locations.

We're seeing a resurgence of schools that aren't getting paying our judges. I think it's reasonable to wait a cycle, or maybe even two cycles (a cycle often is one month for a school district), but if it's been an unreasonable amount of time (>2 cycles), we may consider not assigning judges to future meets until the matter is cleared.

Remind the coaches that middle school and junior high school meets are not prepaid; NAWGJ must receive the \$3 (or \$5 within 30 days) payment before judges can be assigned.

Assignments:

-2-judge panels for all meets

-TAAF: 8 preferred, then 5 (4 events + meet ref)

-Use "Alternate" assignment

-CPE, USAG, NAWGJ status posted on Google Drive

-Encourage judges to complete their credential requirements (including U113)

-Only assign judges who have not met their CPE requirements if no one else is available — pay reduced by \$5 per hour.See above (R&P, p. 36)

-NAWGJ membership must be current - do not assign

*May judge TAAF without a current USAG Membership *May judge High School without a current USAG Membership -Consider mileage to save costs for the Meet Director
