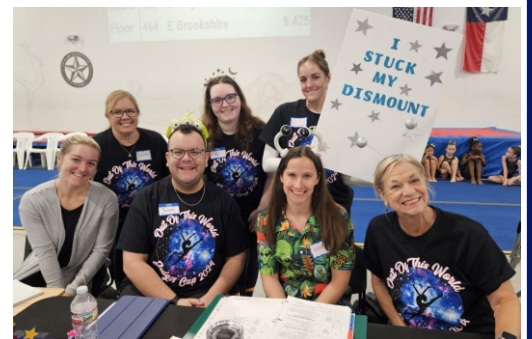
2024 TX NAWGJ Judges' Cup was a huge success! Enjoy the photos from each district!

## Donna Robacker

The code of professional responsibility for NAWGJ was just updated in July of 2024. The code of responsibility consists of three parts: 11 Cannons, 15 disciplinary rules, and the disciplinary actions.

The cannons express the conduct expected of women's gymnastics judges in their relationship with the public, with NAWGJ, and with the profession of judging in general.

The disciplinary rules set forth the minimum level of conduct that is expected of all NAWGJ judges and will be applied uniformly to all members.

The disciplinary actions section describes the process to be used to address complaints about the professional behavior of judges in their role as an NAWGJ member.
